## WATER LEVEL REPORT

Oxtongue Lake Ratepayers Assn. Annual Meeting
August 9, 1995
In our newsletter this Spring we reported that at the end of last Summer we proceeded with an assessment of the dam by Paragon Engineering and based on their recommendation and subsequent MNR approval, proceeded to have the weir or spillway level lowered in hopes that it would result in a more mutually satisfactory water level in 1995.

Our goal was to reach and maintain a level of 363.86 meters above sea level as originally agreed on by the membership before the original restoration work was done and approved by the MNR. The cost was 445.45 for the assessment by Paragon and $\$ 481.50$ to Camecon Construction Co. for the repairs.

The results this year were initially encouraging. At the beginning of June, following what appeared to be a relatively light Spring run off, the level was 364.13 and by the end of June was 363.90 , a little over 1 inch above our goal and we were Feeling very good about the outlook for the Summer.

Then came the rain and storms in July and by the 21 st of that month, the level had gone back up to 364.29 meters, about 15 inches over our target level. It then dropped about 4 inches to 364.20 meters where it has remained until this past weekend when it started dropping again.

A visit to Ragged Falls above the lake and the oxtongue River rapids below the lake demonstrates the large amount of water flowing through the lake and a telephone conversation today, Aug. 8th, with Mr. Henry Check who is responsible for the water levels in Algonquin Park disclosed that they have had so much rain this year that they have not been able to hold some back as they would normally. In a conversation this week with Dan Gibson, a long time resident on Canoe Lake in the park, he said that for the first time in many years, part of his dock has been under water.

The good news, in talking with Mr. Checko, is that he was going to Tea Lake that day and thinks they can reduce the flow which will hopefully result in a better level for us by the Labour Day weekend. This is all dependent on the weather of course.

Following the Labour Day weekend, they will again start drawing down the level at the top of the Park, but Mr. Check assured me that they will do everything possible to avoid any sudden discharge as has happened in the past and will give us as much notice as possible in case of some emergency.
